## ABC Talent Grant April 2021 – Terms and Conditions

**We herewith confirm that your proposal for an ABC Talent Grant is granted!**

The sum of € 125.000 Euro is granted for the project:

Make sense: sensitized brain circuits for rTMS-induced neuroplasticity

to the main applicant, A. Lok, department of Psychiatry, Amsterdam UMC, location AMC hereinafter referred to as: '**the PI**'.

**Please note that in accepting the grant you are also accepting the following terms and conditions:**

### **Article 1      The project**

- 1.1 The Talent, under supervision of the PI, undertakes to, for the duration of the project, to perform the following activities, namely, conducting research in the field of neuromodulation in psychiatry.

### **Article 2      Grant sum**

- 2.1 The granted sum is € 125.000.
- 2.2 AMC Medical Research B.V. ("AMR") is a limited liability company fully owned by the Academic Medical Center and authorized by AMC to be the contracting party for this Agreement on behalf and instead of AMC. For the purpose of this Agreement the task of AMR B.V. is to manage the administration and financial aspects of medical research.
- 2.3 The amount of the granted sum shall be disbursed as follows: 80% in 2021; 20% in 2022

### **Article 3      Project period – 1 year**

- 3.1 The project is planned November 1<sup>st</sup> 2021 until November 1<sup>st</sup> 2022

### **Article 4      Start of the project**

- 4.1 At the beginning of the project, the PI will provide the ABC with a half-page abstract of the project as well as a pitch summary in max. 150 words, both of them in terminology that is accessible to all members of the ABC. This abstract will be posted on the ABC website.
- 4.2 Before the actual start of the project the completed budget form [Appendix B - ABC Talent 2021 Budget] has to be submitted to ABC's controller, Puikang Chan [P.Chan@uva.nl]. After that, the first payment can be processed.

#### **Article 5 Carrying out of the project**

- 5.1 The PI accepts full responsibility for performing the agreed activities in the correct manner.
- 5.2 The PI will plan his/her activities independently. S/he will perform the agreed activities at his/her own discretion, without being supervised or managed by ABC.  
However, in case of
  - a) a major delay or change of direction in the project;
  - b) a conflict between participating researchers;
  - c) inability to comply with the obligations of the assignment properly or in time,the PI must immediately inform the ABC and discuss potential solutions with the ABC.  
In such a case, ABC is entitled to make changes regarding the funding of the project.

#### **Article 6 Completion of the project**

- 6.1 The PI (and his/her team) will provide the ABC with a one-page summary of the project results as well as a pitch summary in max. 150 words [Appendix C - ABC Talent Summary], both of them in terminology that is accessible to all ABC members. This summary will be posted on the ABC website.
- 6.2 The PI (and his/her team) will orally present their results to the members of ABC, at a platform to be agreed upon by both, the PI and ABC.
- 6.3 The PI will send a list of all output (publications, outreach activities, symposia, etc.) resulting from the project to ABC; the PI will provide an updated list if and when additional output is realized after completion of the assignment.
- 6.4 The PI will provide a final financial account of the project to ABC, according to the format provided by ABC.

#### **Article 7 Publications & Grants**

- 7.1 The PI, as well as the Talent, undertakes to always mention ABC, University of Amsterdam in any publications on the research results.
- 7.2 In the case of applying for and /or receiving a Veni grant (or other grant that is being applied for, such as Marie Curie Individual Fellowship) ABC is to be notified.

#### **Article 8 Termination**

- 8.1 This Agreement shall be effective from the start date of the project period, and shall continue in full force until the completion of the project. Each of the Parties is authorized to terminate this Agreement or suspend its obligations with immediate effect in case of a. any material breach of or failure to comply with any of the terms or conditions of this Agreement which cannot be remedied within a reasonable term or if one of the Parties is declared insolvent.  
Termination shall be notified in writing by means of a letter or by email.
- 8.2 Article 2.1, 6, 7 and 9 shall survive the termination of this Agreement.

**9 Assignment**

Academic Medical Center and VU Medical Center have entered into an extensive collaboration under the joint name Amsterdam UMC, which was established by an administrative merger of the Board of Directors of both institutions (in Dutch: bestuurlijke fusie) on 7th of June 2018. Academic Medical Center and VU Medical Center are working towards a full legal merger into a new legal entity. Parties agree that when the Agreement, including any specific clauses that survive the termination or expiration thereof, is still effective at the moment of the legal merger, Academic Medical Center shall have the right to assign all its rights and obligations arising out of and/or related to the Agreement, to the new legal entity without requiring any prior consent and/or prior or further notice.

**10 Applicable Law and Jurisdiction**

10.1 This Agreement shall be governed by the laws of The Netherlands. Any dispute between Parties that cannot be solved amicably, shall be submitted to the competent courts in Amsterdam.
